## 2022 Pension Indexation Award Announced

The Pension Indexation Award is a Teachers' Pension Plan (TPP) design feature that provides inflation protection by annually adjusting your pension benefit amount when the funded status of the Plan is greater than 110%.

The TPP's target Pension Indexation Award is equal to 100% of the change, year-over-year, in the Canada All-Items Consumer Price Index (CPI), which is 0.61% for 2022.

The April 2021 valuation reports the Plan's funded status was well above the 110% threshold; therefore, the full 0.61% will be awarded.

**Funded Status of the TPP  
as at April 1, 2021:**

**117.9%**

**Pension Indexation Award  
effective January 1, 2022:**

**0.61%**

The Pension Indexation Award will be applied January 1, 2022.

Please note, if you retired in 2021, your 2022 award will be pro-rated.

## Change in Deposit Notice Schedule

Effective immediately, your Deposit Notice will be mailed to you anytime there is a change in:

- your gross pension,
- your deductions,
- your bank account, or
- your address.

To notify the Pensions & Benefits office of a change of address, direct deposit information, or tax withholdings, please submit a Pensioner Information Change Form, which can be found on [www.peitpp.ca](http://www.peitpp.ca).

**Expect to Receive At Least Two 2021 T4A Income Tax Slips**

As a result of the recent change in our pensioner payroll system, you will receive at least two T4A Income Tax Slips for 2021:

1. One T4A for the time period of January and February 2021, **and**
2. One T4A for the time period of March to December 2021.

*Please note – Pensioners who receive both regular and spousal TPP pensions can expect to receive more than two T4As.*

For privacy purposes each T4A must be mailed separately. As Income Tax Slips are required to be mailed by the end of February, you can expect to receive all slips by mid-March.

In future years, pensioners will receive one T4A. Exception – those who receive both regular and spousal TPP pensions will continue to receive two T4As.
